II. EXECUTIVE SESSION

Lisa reported that we received our modification for our WPCF permit from DEQ. The deadline to appeal the permit is 5:00pm today. Staff recommendation would be to not appeal the permit but to acknowledge our apprehension about meeting some of their aggressive deadlines with the current availability and shipping times of materials needed being delayed significantly. We may also need more time to get our oxidation ditches to reach the required levels needed in the permit. We will watch the deadlines closely and notify DEQ of any issues that arise as soon as possible. All commissioners agreed to that recommendation and directed staff to not appeal the permit modification. Commissioners directed staff to send a press release out as soon as possible regarding the permit modification from DEQ.
